Thank you for the opportunity to give feedback on the concerns the city council has regarding pet ownership.

In our neighborhood I do not see any animals running at large and have never been near an aggressive animal. I wholly understand situations where there should be concern if animals, most likely dogs, have bitten people or attacked other animals in an unprovoked situation.

I am also very much in favor of pet owners being held accountable for negligence in the care of their animals. Having a pet is a luxury & privilege. Animals in our care need to be safe, protected, and fed. (I would add loved, adored, and reveled in.) If animals are found to be otherwise, then the situations need to be assessed to see if it ongoing abuse or a short time situation. For example, I can understand a dog needing to be tethered in short time situations while a fence is being repaired.

However, my biggest concern, lies within the city itself. I believe the situation at Metro to be unconscionable in its treatment and care of the animals it serves. In my view, it is less a shelter and more of a concentration camp. The rooms for the animals are cold and damp. The cat room has no windows and it doesn't seem there is any way for the cats to be out of their cages. There is an outside area for dogs, but I haven't seen any dogs outside. It appears the animals receive no services from vets, if needed as I know there have been sick animals that were not being treated for their issues. Someone I know adopted a mother cat and kitten from there and sought out care on her own because she saw how sick they were. The kitten would have been blind if not for her seeking care from her own vet and it was touch and go for a while whether or not the kitten would even live. The mother cat was sick as well, but recovered much more quickly. For people like us to see, it was a case of neglect and would not have happened if the kitten would have been treated early and had proper medications. I simply cannot fathom why this shelter allows these animals to go without adequate care. Firstly, the animals deserve medical attention if needed. But, beyond that, the animals are certainly more adoptable if they are healthy. And, why allow any illnesses to be passed throughout the shelter.

I think the council needs to think long and hard about the current situation at Metro especially when it is considering treatment of animals by the general population. I know there would be a rather large expense tied to changes and updates. A good use of the One-Cent Tax would be to update this facility and make it a viable shelter that actually had the health and safety of the animals the biggest priority. There is also a need for a TNR program to help with over population situations (cat colonies, for example). And, it doesn't appear Metro has a consistent spay and neuter process in place.

I have spoken with my vet at length about Metro, my personal concerns, and what could/should be done. I am convinced that many people are unaware of how Metro handles the animals in its care. Because, if so, I think the council would have many animal lovers and advocates very upset.

I am and have been very disheartened by what I have witnessed at Metro. I understand there is a cost involved, but I also know there are other governmental facilities for animal control that don't look like ours. They have areas for the animals to thrive; not waste.

While I know some of this email sounds harsh and accusatory, it is based on my personal interactions with Metro in seeking to adopt pets there. Since that time, I have been very saddened by what I saw and have tried to think of how I might help the animals. As I mentioned earlier, I visited with my vet for suggestions. I saw this offer to respond as a first step, but not my last. I feel the animals in the city's care deserve more than they are getting.

Thanks for the opportunity to respond. Just as you offered my feedback, I welcome a response as well. If there is a place for the me to help, please let me know.

Thank you for considering much-needed change to the current ordinance: The following are my concerns regarding some of the proposals:

1. Requiring that dogs be contained in a fenced yard. My 10-year-old dog has stayed within the boundaries of his unfenced front yard since he was a puppy. This proposal is penalizing dog owners who have spent a lot of time, money and energy training their non-offending pets.
2. Setting the maximum (outside?) temperature dogs can be left in cars at 70 degrees. This is too high –a dog left in direct sunlight could be enduring a lethal temperature far higher inside the car.
3. I have called about loose dogs several times on weekends and evenings and been told animal control is not available at that time. Where will the manpower come from to enforce expanded control?
4. I understand the intent of the proposal is to control dog bites. But I suggest the lack of control over roaming cats is also a problem in the area of health. Who wants to throw out a season of tomatoes because the bed is soiled by cats. And who wants to shut the kitchen window because neighborhood cats have established a litter box outside of it.

I'm pleased there's concern not only for our safety, but for the welfare of animals. If anything, I feel the proposal is overly lenient in giving pet-owners second chances at the expense of innocent animals. Uh, oh. I'm starting to preach - I'll just close with thank you again for your efforts!

I have read the proposed ordinance and submit the following opinion.

ALL OVERDUE and MUCH NEEDED!

It is about impossible to walk the streets where I live--[REDACTED]--when accompanied by a leashed dog without being accosted by another resident's "free-ranging" canine. The unsupervised assailant(s) may simply be in a front yard (the black lab belonging to whoever lives next to the mailboxes comes to mind; its owners can probably read the nearby posted sign stating that an ordinance prohibits loose cats or dogs from their house!) or emerge from beneath a partially opened garage door to rush my dogs. Some time ago a pair of Great Danes "enclosed" in their two-sided back yard by split rail fencing tore after my male, having no difficulty exiting their property down the driveway to advance on us. And an undersized mixed breed was able to leave his back yard by ducking beneath field fence needing repair; he was most persistent when coming for my three mastiffs. (Informed of his dog's confrontational behavior, the owner said he intended to turn over this persistently troublesome pet to animal control.)

I have complained to Metro 2-3 times formally (and had a court date scheduled in one instance after my boy was attacked by a chocolate lab dashing from a garage--the door was raised about a foot--on our way from the mailboxes); I found staff there to be most responsive. What is wrong is Casper's largely inconsequential rules governing pet ownership, not those whose job it is to enforce them.

An aside: Years ago it was suggested to me by the then-president of the Homeowners Association here that I arm myself with a canister of bear spray in order to safely walk my dogs. This was and remains an outrageous fix, to say the least.

Regarding leaving an unintended pet inside a parked vehicle when the outside temperature is 70o, per the American Veterinary Medical Association, in 10 minutes the interior temp rises to 89o. 20 minutes, 99o. And so it goes--in an hour, 115o. Take a look at the organization's 2018 webpage entitled "Elapsed Vehicle Interior Air Temperature v. Elapsed Time" before a decision is made that a cracked window is an adequate solution if the outside temperature isn't quite 70o. (And I recall witnessing show dogs left in their owner-handler's van "safely" with the AC on; when the engine stalled, at least one trapped occupant died of hyperthermia.)

Lastly, I want to bring up what is regarded as adequate provision for a pet's shelter. A Metro worker told me that a parked vehicle is considered suitable housing since a dog or cat can maneuver beneath it to get out of snow or rain. This is appalling indifference.

I hope you will make all essential changes soonest.

Dear City of Casper,

Thank you for your consideration of adapting the proposed ordinance to the safety needs of innocent citizens around unleashed dogs.

I absolutely love animals, especially dogs, and have had many different types of dogs throughout my life. However, I know that many dogs are often prone to instinctual, primal reactions of giving chase depending on variable circumstances (whether it is intended to be aggressive or not, it increases the chances of a bite), or sometimes unexpected dominance gestures of bites, even if the owner of the dog argues or believes that that is impossible. It is VERY possible and is UNPREDICTABLE. It is also an important fact that regardless of how much someone loves their dog, not everyone is fully competent at training their dog.

A brief example is going to a new friend's house last year and her medium sized Labrador who is very friendly, initially jumped on top of me, knocked me down, and while it did not bite me purposely...as I fell, his teeth nipped my lips and I was bleeding with a swollen lip for 2 days. If that happens on accident, think of the damage that can be done if the dog is being purposely aggressive. This is an example that highlights why it would be important for an otherwise 'friendly' dog to be leashed when a new person or unknown person is nearby.

You don't know exactly how the dog will react to different people, and until that person knows and establishes a relationship with that particular dog, safety risks should be eliminated. A responsible and competent dog owner knows how to train your dog to BEHAVE publicly, but how exactly do you test for that? The solution is the generalized law that you are considering. I was shocked to read that they were over 700 dog bites in the city of Casper between 2017 and 2018, that's a lot more than I would've guessed. It doesn't matter if it was a post office delivery person, or a child walking home from school; **what is relevant is that clearly there is a risk to public safety.**

More importantly, dog owners need to be **REALISTIC** and understand that no matter how much they love their pet, even if the dog has a 'perfect' history, that doesn't mean nothing will ever happen. Once a bite does happen, then there is damage and it could be severe, depending on the bite. "MY SAFETY FIRST, your feelings second" philosophy is definitely applicable.

Now I have an issue with a dog being chained for more than a few hours in its own yard IF the yard is fenced, again unless someone is new and going to be near the dog. As long as the dog cannot jump the fence, I don't think there is anything inherently dangerous with the dogs running free in its own FENCED yard. Responsible dog owners, including myself, know that the first time a new person is near a dog it should be leashed and properly introduced. Most dogs respond to new people according to how they have been trained, and very importantly, if their dog owner is right next to them. Even then, there is no guarantee, only likelihood.

I do understand that many dogs have never bitten, but again, that does not mean they never will. **There are still unknowns that we continue to learn about dogs' reactions in different situations and around different types of people.**

Dogs by nature test boundaries with humans and with other dogs. It is the way they think, socialize, and interact with other beings. Dogs have established (or will establish) dominance hierarchies, even with humans around them. As a person who has experience rescuing dogs and rehabilitating them as a foster parent, I express this truth with credibility.

In nature dogs may nip each other to establish dominance sometimes. That is not something that can be predicted. Therefore it is perfectly REASONABLE and just to ask dog owners to make sure their dog is not loose and able to possibly bite a person, ESPECIALLY if they are OUTSIDE of their RESIDENTIAL domain.

I agree with the City Council representative that mentioned concerns regarding loose dogs in pickup trucks growling at passersby, getting aggressive with someone just walking by with their own dog. All the growling dog has to do is simply jump out and attack, it would take a few mere seconds. That is dangerous to innocent others whose rights to safety should be respected. **In fact, the right to feel safe is paramount above any other rights. Threat of potential physical injury trumps any other 'rights'.**

I write all of this as someone who absolutely loves dogs. I also have educated myself over the years, I also have credible experience working in dog rescue groups as well, and learned by real experience about how dogs think and respond.

My main point is, **dog owners have a responsibility for the safety of innocent others, regardless of their feelings that their dog probably would not chase or bite, the reality is, no one can guarantee that 100%.** Even my own lovely dogs throughout my lifetime, that I love and cherish deeply, are still very capable of biting aggressively, inflicting potential injury, even if in the dog's mind it is just a nip: Sharp canine teeth can cause a lot of flesh and tissue damage in a heartbeat.

It is also nearly impossible to out run a dog unless you are a professional marathon runner or a Marine, and even then, it would be a challenge. Most dogs can quickly and easily out run any human. I have been chased by a dog as a child (I'm an adult now of course), and it was terrifying. It was a loose dog that had its owner about 10 feet away and he did absolutely nothing except laugh as I had to climb up a tree as it barked aggressively like I was its prey trembling up a tree. People should be able to walk about the city without having to worry every time they see a loose dog what might happen to them. *(And not everyone can just climb up a tree to stay safe, nor should they have to.)*

**That's not a risk anyone should have the right to take and decide that my safety is secondary to their feelings.**

Please consider these reflections, and I remain very confident that I am the voice of many people across our city who would like you to pass the ordinance ***prioritizing their safety.***

If the city is considering amending or enforcing the animal care ordinances, I would hope that you will address spaying and neutering of animals.

Many cities have required spaying and neutering of companion animals and in doing so, have not only built more responsible pet ownership, but have drastically reduced the number of unwanted animals that are abandoned, injured, end up in the few available shelters, and yes bite people or are aggressive to other animals.

Our local animal shelter, Metro Animal Control, should take the lead in this by spaying and neutering all animals before adoption, age/health permitting, and require substantial \$\$ deposits if the animal is too young – refundable deposit when the procedure is done.

Those pet owners who do not wish to spay/neuter their animals should be required to apply for a one year permit to leave the animal unneutered, and the cost should be significant ( at least \$500 -- they'll make plenty on the puppies they sell). Their fee could help pay for the enforcement of the requirement or to pay for spay/neuter of the animals at Metro.

If you are looking for responsible pet ownership – it starts with spaying and neutering companion dogs and cats.

Your proposed new ordinances will not change anything! For the 20 years I have lived in my house, I have had to deal with vicious pit bulls, coming onto MY property, attacking my pets, attacking other dogs, and kids on bikes in front of my house! I have a disAbled son, and we live in fear of a dog attack daily. Metro has been called, the police have been called, we have gone to court several times. We even got a petition signed by over 200 neighbors once, to make the City do something about a pit bull dog that terrorized our entire neighborhood, even killing other animals. The last problem we had was a neighbor who had THREE, yes three pit bulls. We have a security system, which we HAD to get to prove what was happening with these pit bulls, thinking it would help our case. Repeatedly, we videoed his dogs coming to our front fence, and into our driveway, to get at our dogs, metro refused to do anything except issue a dog at large citation. And this was after an instance, when one of his pit bulls, climbed my back gate and attacked my Lab, leaving several puncture wounds in my dog's neck. Time and time again, we called Metro on these dogs, other neighbors did as well. Nothing was done, he was cited, that's it. Metro said that until the dog actually hurts someone, they couldn't do anything else. So someone has to get hurt, possibly die before anything is done???? Then that neighbor simply moved to another neighborhood, taking his killer dogs with him!

Yes Labs bite, cats bite, German Shepherds bite - But once they bite, they release. A pit bull doesn't bite and release, they take their victim down. It's NOT about how they are raised, it's in their DNA. And I can almost guarantee that the 'lab' bites in your study are not full blood Lab, but lab-pit mix. Look at the dogs in Metro, how many are Pitbull or pit mix? How many owners say their pit bulls are the most loving, gentle dogs, and would never hurt anyone....until they kill a child for no reason. Look it up, not one owner of a pit bull that attacked says that their dog was unpredictable, or couldn't be trusted.

Now I have two small dogs. When I walk them, I have to carry a gun, yes a loaded gun. I am to the point now, that if a pit bull ever comes onto my property again, or approaches me while walking my dogs, I will not think twice, I will shoot the dog! 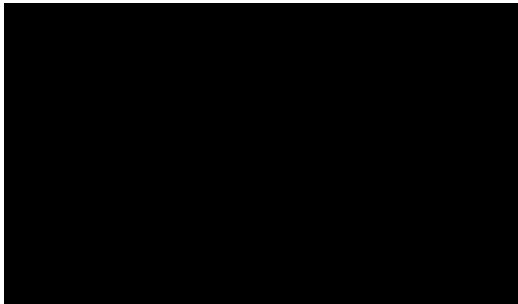

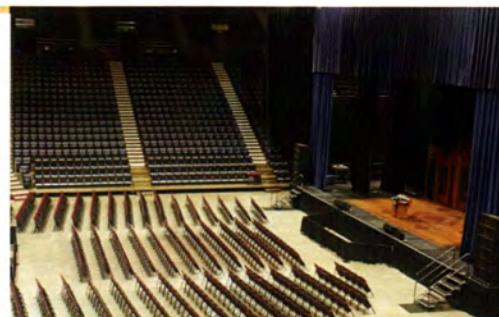

## Is your food better than his?...

Of course dogs think so! Just remember, that dog food is formulated for dogs and some people food can actually be harmful to your furry friend...some of those are:

- **Avocados** (contain persin, can cause vomiting and diarrhea)
- **Onions and garlic** (kills red blood cells, causing anemia)
- **Caffeine** (can easily be fatal)
- **Grapes and raisins** (can cause kidney failure)
- **Dairy** (difficult to digest properly)
- **Macadamia nuts** (just a few can cause muscle shakes, fever, vomiting)
- **Chocolate** (contains theobromine, dark and unsweetened baking chocolate are the worst)
- **Fat trimmings and bones** (can cause pancreatitis and bones can splinter damaging his digestive system)
- **Raw eggs, meat and fish** (can have bacteria or parasites)
- **Xylitol** (found in candy, gum, toothpaste, baked goods, etc) known to cause liver failure)
- **Never give your dog human medicine unless your veterinarian directs you do to so** (acetaminophen or ibuprofen are often fatal)

If your dog eats something he shouldn't, contact your vet immediately or the ASPCA Animal Poison Control Center at (888) 426-4435.

And if you can't resist those big, brown eyes and want to give your dog a treat – dogs can eat cooked plain white rice or pasta with some boiled and boneless chicken.

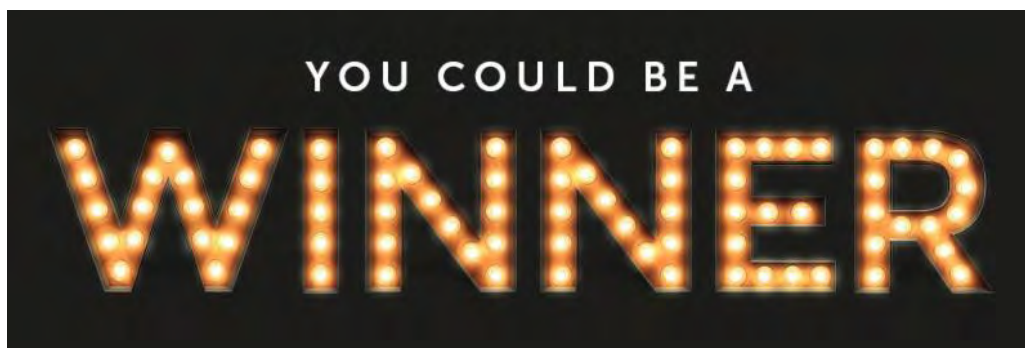

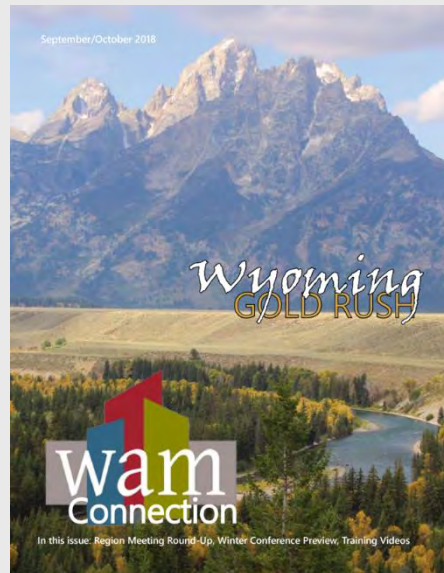
