SUBJECT: Neptune Water Meters

Attached is a product support document (PSD) for the City's Neptune E-Coder registers on residential water meters for inclusion in the info packet. Casper has been using these registers for the last six to eight years, and have found that customers actually find them easier to read than the old wheel style. The customer can shine a flashlight on the "solar panel" to make the display active.

## How to Read the Neptune E-CODER® Register

To read your Neptune E-CODER® register, expose the solar panel to sunlight or shine a bright light (i.e. flashlight or cell phone flashlight), and the display will activate.

When activated, the LCD display will first show a segment test:



This screen will be followed by the display of the E-CODER's manufacturing configuration, followed by two (2) reading screens:

**Reading** - Shows the current read with comma separators and decimal place, after initial activation this screen displays for 20 seconds before toggling to Rate Screen. Each additional Read Screen displays for 8 seconds. The below image shows a reading value of 179.21 (one hundred, seventy-nine) US gallons.



GALLONS (GPM)

**Flow Rate** - When the screen toggles, the rate of flow is visible and is shown in gallons per minute for four seconds. Then it toggles back to the read screen. The image below shows a flow rate of 50.7 (fifty) gpm.

#### Summary

As a part of the Land and Water Conservation Fund (LWCF) grant application process, and in following council goals regarding public engagement, a public survey was deployed and two public meetings were held to discuss the proposed improvements for the Washington Park Revival Project. There were 44 participants in the public meetings and 422 responses to the survey. In general, participants expressed overwhelming support for enhancements at the park, and there was not strong opposition to any of the recommended improvements. The attached charts summarize the data collected through the survey. This information will be shared with participants on the City's website dedicated to the Washington Park Revival and submitted as part of the City's LWCF grant application.
