MINUTES from Meeting Held on Thursday, November 21, 2019 at 3:00 PM Downstairs Meeting Room, City Hall, 200 North David Street, Casper

- 1. Introductions/Roster Sign-in
- 2. <u>Minutes from October 24, 2019 Meeting</u> A motion was made by Nikki Green and seconded by Art Pauly, Jr. to approve the minutes, and the voting members voted to accept the minutes from the previous meeting.
- 3. Due to the inclement weather, the team from Confident Navigator was not able to be at the meeting to present. We hope they will make it to the next meeting.

4. Old Business:

- Possible meeting time change: Continued discussion took place regarding an alternative meeting time. It was mentioned that possibly 11:30-1 PM on the 4th Thursday could work, and have a working lunch. It was moved by Zulima Lopez and 2nd by Renate Pullen to move the meeting time to 11:30 AM to 1 PM, still on the 4th Thursday of the month. The Council approved this time change to begin at our next meeting.
- The Council decided to move the agenda item from the end of the meeting to this section to decide on the next meeting date as the 4th Thursday falls on December 26th. It was moved by John Wall and 2nd by Zulima Lopez to move the agenda item to Old Business, and this was approved by the Council. It was decided by the Council to hold our next meeting on Thursday, December 19th, 2019 from 11:30 AM-1 PM.
- Eric Distad, Austin Berlin's Alternate, Council Chairperson, lead the meeting with discussion from each established Committee Chairperson:
 - QOL Committee Mary Price has resigned from the Council, and Zulima Lopez agreed to accept the Chairperson role for the QOL Committee. Luan Plumb requested to be a member of the QOL Committee.
 - Public transportation expansion and operating times:
 - Zulima Lopez provided an update. Zulima contacted John Jones, Executive Director of CATC, and he is still interested in working with the Council although Mary has resigned. CATC

- will continue to determine if they will have a fixed route to the new VA location on the east side of town or if that will be by request only or scheduled, and the fare required.
- Bonnie noted that some VA provides transportation to appointments but it was believed it was in Sheridan or Cheyenne, but not local transportation in Casper.
- Public Relations (PR) Committee John Wall, Chairperson
 - John Wall let the Council know that a draft version of the Council Facebook page has been established but is not live yet (has not been published). The Council needs to decide on the content first. It was decided that Council members come prepared with main content ideas for review and approval at our December meeting.
 - John Wall discussed more collaboration with other entities to participate in events and fundraisers as well as engage other businesses, and discussed including the State Rehabilitation Council (SRC), a state-wide organization, Ripple Award on our Facebook page. This will be discussed and reviewed at the next meeting.
 - Zulima Lopez reported that a request has been submitted to the City of Casper IT Department to establish a web page dedicated to the Disability Council on the City of Casper's website. Once the page is established and operational, the Council will need to decide on the content. This is pending. Jeremy Yates, Administrator in the City Manager's office, is working on this project.
 - Zulima Lopez let the Council know that an email address established for the Council was approved. This email address is disabilitycouncil@casperwy.gov
- Events Committee Nikki Green, Chairperson
 - Nikki Green provided an update to the event for Casper Disability Day in March, 2020, and the proposal is attached to these minutes. She was able to contact multiple venues and get costs. A motion was made by Renate Pullen and 2nd by Michelle Onstott to book the Ramkota Hotel & Conference Center on March 14, 2020 for Casper Disability Day, and the Council approved this. The Ramkota requires no money up front. This also brought up more conversation about availability of funds, and availability for vendors to reserve a booth and pay on the Facebook page or the City's website page.

- Zulima Lopez reported that they've reached out to the Cheyenne Council and their Council has no budget and no funds, and is strictly a group of volunteers dedicated to the issues facing people with disabilities.
- Nikki asked about Save the Date cards or invitations or vendor letters for the event, and the events committee can work on this and get a proposal for the Council.
- Mayor Powell noted that anyone can make donations to the City of Casper marked for certain projects. Funds are set aside for Community Relations for events that benefit the city such as hotel rooms or events that bring in money from out of town. The type of funds include in-kind like access to the Events Center, which would provide for 50% off the price, or cash for running the event. The City Council is more stringent about the cash.
- Fundraising Committee Linda Jones, Chairperson
 - (Previously established goal of the Fundraising Committee) After further information is gathered from the City & provided by Zulima, look into the non-profit status for the Council to be able to have the fundraising be tax-deductible. Zulima Lopez has reached out to the City Attorney and Financial Services Director to discuss the issue of tax-deductible donations and this is pending. The update from the Cheyenne Council was given in the above Events Committee report and update.
 - Linda Jones proposed having a bake sale around Easter to benefit the council. Linda studied the rules for a bake sale, and the Wyoming Original Cottage Food Law needs to be followed. No samples are to be given out, and people must buy food and take it home and consume it. You can sell canned goods. There is no sales limit. There should be at least 20 items she thinks about 60-100 items at least. Direct sales only. Discussed writing a receipt for each sale and give the copies to the Treasurer.
- 5. <u>New Business</u>: Due to the time and other parties needing the meeting room, the agenda item about adding new members was tabled until the next meeting. Zulima Lopez made a motion and it was 2nd by Bonnie Wilson to table this agenda item until the next meeting, and the Council approved.

The meeting adjourned at 4:00 PM. The next meeting will be held on <u>Thursday</u>, <u>December 19</u>, <u>2019 at 11:30 AM</u> at City Hall.

November 21, 2019

OVERVIEW

1. Project Background and Description

i Per the Bylaws created for the Casper Council for People with Disabilities, Article, IX, Standing Committees, 3. Events Committee, item b), "The Events committee shall annually plan a CCPD community awareness and education Town Hall meeting event in a month selected by the PR Committee and approved by the CCPD. In addition, the Events Committee shall provide information to the community and raise funds for the CCPD."

The Events committee proposes "Casper Disability Day". An annual event that will be held each year during March in honor of disability awareness month. The event will provide the opportunity for local providers and services to host a booth with information about the services that they provide. The event will be open to the public. Additionally, the event will provide opportunities for guest speakers to talk about things disability related.

2. Project Scope

The Events Committee will contact local businesses that can house a large number of people (Events Center, Fairgrounds, Ramkota and Clarion). The plan is to offer the event on a Saturday from approximately 9-3. At this time, the rental of the facility will be covered by the cost of the booth rental. Food will be determined based on the location determined.

3. High-Level Requirements

Recruitment of vendors will be a major issue. The plan is to utilize the provider list supplied by the QOL committee.

4. Deliverables

The event will provide a fun and informative way for the citizens of Casper to learn about the abundance of resources available to those with disabilities. The event will create awareness about the CCPD.

Dear Sir:

I noted the article in yesterday's Star Tribune about your concerns for the LBGTQ community and their rights. I find myself confused because as everyone knows people cannot just be dismissed because of their political or personal views. This certainly is true of the LBTQ community. You seem to be demanding more, but I don't believe that more can be done when it comes to protection under law.

What concerns me is that demands for LBGTQ rights sometimes have a hidden agenda which is that the public at large has to accept the sexual orientation or homosexual orientation that the LBGTQ community advocates. Here is the problem that many have: The three greatest religions, Judaism, Christianity, and Islam have declared for thousands of years that homosexuality is wrong, and it is wrong, I believe, to turn our back on thousands of years of wisdom claiming, by the way, to have come from God.

For Christians, the command is to love our neighbor as ourselves. If I encourage homosexual behavior, then I am not loving my neighbor. I am rather promoting something that is dangerous and injurious to others. The example is anal intercourse, which any honest doctor will tell you is fraught with danger even if protection is used or not. I have asked people if they would go to a restaurant where the employees did not wash their hands after using the restroom. I have yet to find anyone who said that they would, and yet anal intercourse is much more dangerous in spreading disease and creating physical problems including more susceptibility to cancer. This is clearly why various religious groups have condemned such activity. How can I say I love my neighbor if I say to two men it is OK to have anal intercourse?

I believe in LBGTQ rights just as I believe that anyone has the right to their personal views. However, respecting their rights does not means that I have to accept their views, nor am I a 'hater' because I don't.

As many of you know, the Joint Corporations Committee passed a bill through to session this week that poses a serious preemption threat to your ability to offset negative financial impacts of development in your communities. While the bill is specifically aimed at pleasing a handful of wealthy developers who disagree with Jackson's housing mitigation ordinance, it stands to take away your ability to use school and park



exactions, by making it illegal for cities, towns and counties to require developers to help defray the costs of capital improvements needed for public facilities as a condition of development approval. In an effort to build our case to kill this bill we would like to know if your municipality currently or has used school or park exactions.
