

SCHEDULE OF MECHANICAL FEES

PERMIT ISSUANCE

For the issuance of each permit\$20.00
For the issuing each supplemental permit for which the
original permit has not expired, been canceled or final inspection made....\$10.00

Furnaces:

For the installation or relocation of each forced-air or gravity-type
furnace or burner, including ducts and vents attached to such
appliance, up to and including 100,000Btu/h (29.3kW).\$15.00

For the installation or relocation of each forced-air or gravity-type
furnace or burner, including ducts and vents attached to such appliance
over 100,000 Btu/h (29.3 kW).\$20.00

For the installation or relocation of each floor furnace,
including venting.\$15.00

For the installation or relocation of each suspended heater,
recessed wall heater or floor-mounted unit heater.\$15.00

Appliance Vents:

For the installation, relocation or replacement of each appliance
vent installed and not included in an appliance permit \$15.00

Repairs or Additions:

For the repair of, alteration of, or addition to each heating appliance,
Refrigeration unit, cooling unit, absorption unit or evaporative cooling
system, including installation of controls and the alteration of heating
ducts regulated by the Mechanical Code. \$15.00

Air Handlers:

For each air-handling unit to and including 10,000 cubic feet
per minute (4720 L/s), including ducts attached thereto. \$12.50

NOTE: This fee does not apply to an air-handling unit
which is a portion of a factory-assembled appliance, cooling
unit, evaporative cooler or absorption unit for which a permit
is required elsewhere in the Mechanical Code.

For each air-handling unit exceeding 10,000 CFM (4720 L/s) \$20.00

Boiler, Compressors, Absorption Systems and Air Conditioners:

For the installation or relocation of each boiler or compressor to and including three horsepower (10.6 kW), or for each absorption system to and including 100,000 Btu/h (29.3 kW).....\$15.00

For the installation or relocation of each boiler or compressor over three horsepower (10.6kW) to and including 15 horsepower (52.7kW), or for each absorption system over 100,000 Btu/h (29.3 kW) to and including 500,000 Btu/h (146.6 kW).\$30.00

For the installation or relocation of each boiler or compressor over 15 horsepower (52.7 kW) to and including 30 horsepower (105.5 kW), or for each absorption system over 500,000 Btu/h (146.6 kW) to and including 1,000,000 Btu/h (293.1 kW) \$40.00

For the installation or relocation of each boiler or compressor over 30 horsepower (105.5 kW) to and including 50 horsepower (176 kW), or for each absorption system over 1,000,000 Btu/h (293.1 kW) to and including 1,750,000 Btu/h (512.9 kW)\$55.00

For the installation or relocation of each boiler or compressor over 50 horsepower (176 kW), or for each absorption system over 1,750,000 Btu/h (512.9 kW)..... \$90.00

Evaporative Coolers:

For each evaporative cooler other than portable type
(\$10.00 permit fee is waived for evaporative coolers)\$15.00

Ventilation and Exhaust:

For each ventilation fan connected to a single duct\$10.00

For each ventilation system and duct work which is not a portion of heating or air-conditioning system authorized by a permit\$15.00

For the installation of each hood which is served by mechanical exhaust, including the ducts for such hood.\$15.00

Incinerators:

For the installation or relocation of each domestic-type incinerator.\$25.00

For the installation or relocation of each commercial or industrial-type incinerator.\$75.00

Fireplaces:

For the installation of a solid fuel burning appliance (fireplace). \$12.50

Miscellaneous:

For each appliance or piece of equipment regulated by the Mechanical Code but not classed in other appliance categories, or nor which no other fee is listed in the code. When Appendix B, Chapter 13, is applicable (see Section 103), permit fees for fuel-gas piping shall be as follows:\$12.50

For each gas-piping system of one to four outlets\$ 7.50

For each gas-piping system, additional outlets over five, each\$ 3.00

When Appendix B, Chapter 14, is applicable (see Section 103), permit fees for process piping shall be as follows:

For each hazardous process piping system (HPP) of one to four outlets\$7.50

For each piping system of five or more outlets, per outlet\$3.00

For each non-hazardous process piping system (NPP) of one to four outlets.\$4.00

For each piping system of five or more outlets, per outlet\$1.00

OTHER INSPECTIONS AND FEES:

Inspections outside of normal business hours, per hour (minimum charge – 1/2 hour) \$48.00

Re-inspection fees assessed under provisions of Section 116.6, per inspection \$48.00

Inspections for which no fee is specifically indicated, per hour (minimum charge – 1/2 hour)\$48.00

Additional plan review required changes, additions or revisions to plans or to plans for which an initial plan review has been completed..... \$48.00
