Mayor Freel opened the public hearing for the consideration of the annexation and plat creating the East Robertson Road Addition and 3489 South Robertson Road.

City Attorney Henley entered two (2) exhibits: correspondence from Liz Becher to J. Carter Napier, dated January 6, 2021 and an affidavit of publication, as published in the <u>Casper-Star Tribune</u>, dated January 6, 2021. City Manager Napier provided a brief report.

There being no one to speak for or against the issues involving the East Robertson Road Addition and 3489 South Robertson Road, the public hearing was closed.

Vice Mayor Pacheco presented the foregoing ordinance for approval, on first reading. Seconded by Councilmember Gamroth.

Councilmembers Knell, Engebretsen, Gamroth and Pollock had questions about the annexation process and the particulars of this location. City Manager Napier addressed these concerns. Mayor Freel and Councilmember Engebretsen abstained. Motion passed.

Councilmember Cathey presented the foregoing ordinance for approval, on second reading. Seconded by Vice Mayor Pacheco.

No citizens addressed Council.

Moved by Vice Mayor Pacheco to amend Section 9.24.050, Subsection A., deleting reference to Wyoming Statute Section 6-4-104 on line three, and replacing it with Wyoming State Statute Section 6-4-101, to correct the typographical error. Seconded by Councilmember Cathey. Motion to amend passed. Council then voted on the ordinance, as amended, on second reading. Motion passed.

Councilmember Pollock presented the foregoing four (4) resolutions for adoption. Seconded by Councilmember Knell. Motion passed.

10. MINUTE ACTION—CONSENT

Moved by Councilmember Engebretsen, seconded by Councilmember Gamroth, to, by consent minute action, authorize the purchase of one (1) new fire chassis and body from MaxFire Firefighting Solutions, in the total amount of \$628,004, before trade and authorize appointments to the Council's Boards and Commissions. Motion passed.

11. INTRODUCTION OF MEASURES AND PROPOSALS

Councilmember Knell shared concerns with the following items: parking along 12th and 13th Streets, a new Police station, facility conditions at the Speedway, and the tobacco ordinance. Councilmember Pollock spoke about transparency and use of the consent agenda to pass items as well as snow removal at bus stops. Mayor Freel asked if more information could be provided at a work session regarding the consent agenda, and City Attorney Henley stated that would be fine. Councilmember Cathey and Vice Mayor Pacheco spoke about the COVID-19 pandemic.

City Manager Napier asked for direction on bringing the Police station item and the parking along one-ways issue forward to a work session. Mayor Freel indicated that these each should be set for a future work session.

Mayor Freel spoke about the unified command that was a joint effort to manage the pandemic situation. He suggested that we exit from the unified command and let the Natrona County Health Department manage things going forward. Councilmembers Knell and Pollock spoke on the matter. City Manager Napier provided more information on the process of standing down from the effort. Council provided support for staff to prepare a resolution for the City to step down from the command.

12. ADJOURN INTO EXECUTIVE SESSION

Mayor Freel noted the next meetings of the City Council will be a work session to be held at 4:30 p.m., Tuesday, January 26, 2021, in the Council Chambers; and, a regular Council meeting to be held at 6:00 p.m., Tuesday, February 2, 2021, in the Council Chambers.

At 7:08 p.m., it was moved Councilmember Knell, seconded by Councilmember Pollock, to adjourn into executive session to discuss personnel. Motion passed.

At 7:55 p.m., it was moved by Councilmember Cathey, seconded by Councilmember Knell, to adjourn the executive session. Motion passed.
