I. MINUTES OF THE PREVIOUS MEETINGS

<u>Chairman King</u> asked if there were additions or corrections to the minutes of the June 18, 2020 Planning & Zoning Commission meeting. There were no meetings in either July or August.

<u>Chairman King</u> called for a motion to approve the minutes of the June 18, 2020 Planning & Zoning Commission meeting.

Mr. Hein made a motion to approve the minutes of the June 18, 2020 meeting. The motion was seconded by Mr. Wingerter. All those present voted aye. Motion carried.

II. PUBLIC HEARING
