Several Councilmembers shared their thoughts on the comments and encouraged the organization to apply for community promotions in the future. Council discussed providing in-kind funding to cover the police officers required for this event and gave their thumbs up to provide 100% in-kind funding for Police support at the awareness parade in May.

Other individuals addressing Council included: Mike Pyatt, 3841 East 15th St, regarding an abortion clinic. City Attorney Henley addressed questions from Mr. Pyatt regarding the City's authority and regulations.

Mayor Pacheco opened the public hearing for the consideration of Microbrewery License No. 4 for Frontier Brewing Company.

Carter Napier, dated March 17, 2022; an affidavit of publication, as published in the <u>Casper-Star Tribune</u>, dated April 18, 2022; an affidavit of website publication, as published on the City of Casper website, dated April 13, 2022; and a liquor license application, filed March 4, 2022. City Manager Napier provided a brief report.

There being no one to speak for or against the issues involving Microbrewery License No. 4, the public hearing was closed.

Moved by Councilmember Johnson, seconded by Councilmember Sutherland, to, by minute action, authorize the issuance of Microbrewery License No. 4. Councilmember Pollock, having recused herself, abstained from voting. Motion passed.

Councilmember Pollock rejoined the meeting.
